1. THE EVENT WILL BE A MOTORCYCLE RALLY AND LIVE MUSIC FESTIVAL WITH CAMPING AND MEALS/BEVERAGES AND ALL PROCEEDS WILL FUND THE SOUTHERN MOTORCYCLE RALLY FOR VETERANS
2. HOSTED AND OPERATED BY THE SOUTHERN VIRGINIA MOTORCYCLE RALLY AND ITS STAFF.
3. THE EVENT WILL BE HELD AUGUST 23RD - 24TH 2019 WITH CHECK IN BEGINNING FRIDAY 23RD AT 3PM AND DEPARTURE TIME AT 11AM SUNDAY 25TH.
4. ENTERTAINMENT WILL BE SCHEDULED TO INCLUDE 2 REGIONAL BANDS AMPLIFIED AS WELL AS ACTIVITIES LED BY TRAINED STAFF
5. MUSIC WILL BE AMPLIFIED AND PERFORMED ON A TEMPORARY STAGE SET UP BY SOUTHERN VIRGINIA BIKE RALLY FROM 4:30PM AUGUST 24TH TILL 10PM THAT EVENING.
6. THE STAGE WILL BE SET UP TO FACE WEST ON THE 7.5 ACRE PROPERTY SO AS TO MANAGE THE VOLUME. STAGE AND SOUND WILL BE DIRECTED AWAY FROM ADJOINING RESIDENCES. THE LEVEL OF MUSIC AND OTHER NOISE CREATED BY THE GATHERING WILL BE TESTED AND ADJUSTED SO AS TO NOT DISTURB THE CLOSEST RESIDENT

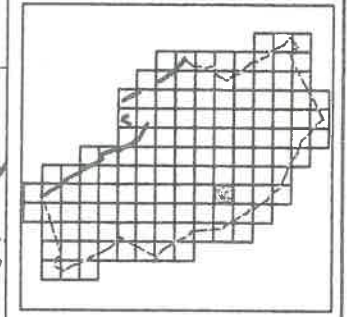
