ARTICLE II. ELECTION DISTRICTS PRECINCT BOUNDARIES***Sec. 18-26. Apportionment of county into districts, precincts, and polling places.**

Pursuant to the authority contained in the Code of Virginia, 1950, as amended, the County of Craig, Virginia, is hereby apportioned into five election districts with the election districts, precincts and polling places as hereby created and established as set forth in this article. (Ord. No. 01-05, § 1, 6-19-2001; Ord. No. 11-09, § 1, 7-7-2011)

Sec. 18-27. Establishment of new election districts.

The election districts with populations, according to the most recent United States census, are hereby established as follows:

Craig Creek District	1,003
Craig City District	1,082
Potts Mountain District	1,071
Simmons ville District	1,018
New Castle District	1,016

Sec. 18-28. Election district boundaries.

The boundaries of the respective election districts are established as follows:

Craig Creek District

Beginning at corner of Craig County and Montgomery County, at the top of Sinking Creek Mountain.

Thence, in a southeasterly direction, following the boundary line between Craig County and Montgomery County, to corner "I" on the old Craig County Survey, corner Roanoke County, Montgomery County, and Craig County.

Thence, in a northeasterly direction, following the Roanoke County line to corner "L" on the old Craig County Survey, corner to Roanoke County, Botetourt County, and Craig County.

Thence, continuing in a northeasterly direction, following the Botetourt County line along the top of North Mountain to a point where Route 606 crosses the County line.

Thence, in a northwesterly direction along Route 606 to the intersection of Route 614.

*State law reference—District boundaries, Code of Virginia, §§ 24.2-304.1, 24.2-306.

Thence, in a southwesterly direction along the centerline of the right-of-way of Route 614 to the point where Craig Creek intersects under Route 614.

Thence, upstream with Craig Creek to the point where it intersects with Johns Creek.

Thence, upstream with Craig Creek to the point where it intersects with Meadow Creek.

Thence, upstream with Meadow Creek, following a portion of the National Forest Boundary, to the point where it intersects with National Forest Boundary just south of Route 42.

Thence, in a southern direction, along the National Forest Boundary, and along the ridge to the top of Sinking Creek Mountain.

Thence, in a southwesterly direction along the ridge top of Sinking Creek mountain to the corner to Craig County and Montgomery County, the starting point.

Craig City District

Beginning at the intersection of Route 611 and Route 615 near Barbours Creek.

Thence, in a westerly direction along Route 611 to the point where Route 611 intersects with Route 311.

Thence, in a southeasterly direction along Route 311 to the point where Route 311 intersects with Johns Creek.

Thence, in an easterly direction along Johns Creek to the point where Johns Creek intersects with Craig Creek.

Thence, in a northeasterly direction along Craig Creek to the point where Route 614 crosses Craig Creek.

Thence, in a northeasterly direction along Route 614 to the point where Route 614 intersects Route 615.

Thence, in a northeasterly direction along Route 615 to the point where Route 615 intersects Route 611, the starting point.

Potts Mountain District

Beginning at the intersection of Route 611 and Route 615 near Barbours Creek.

Thence, in a westerly direction along Route 611 to the point where Route 611 intersects with Route 311.

Thence, in a southeasterly direction about 1.6 miles along Route 311 to a point in the southern portion of the turn which is approximately 1.1 miles due south of the intersection of Meadow Branch and Route 611.

Thence, in a southeasterly direction to a point on top of Johns Creek Mountain, about .75 miles west of Alps Knob and in a straight line with the intersection of Route 42 and Route 624 and the previous point on Route 311.

Thence, in a westerly direction along the ridge of Johns Creek Mountain to a point where Johns Creek Mountain Trail, also known as National Forest Trail 57-2, intersects the Appalachian Trail near the Giles County line.

Thence, in a southerly direction along the Appalachian Trail to the knob just north of Kelly Knob.

Thence, due south to the Craig County and Giles County line to a point just west of Kelly Knob.

Thence, in a northerly direction along the Giles County and Craig County border to a point at the intersection with the West Virginia border.

Thence, in a northeasterly direction along the border with West Virginia to a point on the top of Peter' s Mountain, being the intersection of the West Virginia, Craig County and Alleghany County lines and shown as "B" on the old Craig County survey.

Thence, in a southeasterly direction along the Alleghany County and Craig County line to a point to which Alleghany County, Botetourt County and Craig County join and shown as "N" on the old Craig County survey.

Thence, in a southerly direction along the Craig County and Botetourt County line to a point at the intersection of Route 606 that is also a comer for the Craig Creek District.

Thence, in a northwesterly direction along Route 606 to the intersection of Route 614.

Thence, in a southwesterly direction along the centerline of the right-of-way of Route 614 to the point where Craig Creek intersects under Route 614.

Thence, upstream with Craig Creek, past the first intersection with Route 614 to the point where it intersects Route 614 a second time.

Thence, in a northwesterly direction along Route 614 to the intersection with Route 615.

Thence, in a northerly direction along Route 615 to the intersection of Route 611, being the same point as beginning.

Simmons ville District

Beginning at the intersection of Route 42 and Route 624.

Thence, due south to the top of Sinking Creek Mountain.

Thence, in a southwesterly direction along the top of Sinking Creek Mountain to a point in the Montgomery County and Craig County line.

Thence, in a southwesterly direction along the Montgomery County and Craig County line to the comer where the lines intersect the Giles County line.

Thence, in a northwesterly direction to a point on the Giles County and Craig County line, just west of Kelly Knob.

Thence, in a northerly direction to a point on the unnamed knob just north of Kelly Knob.

Thence, joining the Appalachian Trail and following the trail in a northerly direction to the intersection with Johns Creek Mountain Trail, also known as Forest Service Trail 57-2.

Thence, in an easterly direction along the top of Johns Creek Mountain to a point on top of Johns Creek Mountain. 75 miles west of Alps Knob and also forming a comer of the Potts Mountain District.

Thence, in a southeasterly direction to the intersection of Route 42 and Route 624, point of beginning.

New Castle District

Beginning at the intersection of Johns Creek and Craig Creek, a common comer with Craig Creek District and Craig City District.

Thence, upstream with Craig Creek to the point where it intersects with Meadow Creek.

Thence, upstream with Meadow Creek to the point where it intersects with National Forest Boundary just south of Route 42.

Thence, in a southern direction, along the National Forest Boundary, to the point on the top Sinking Creek Mountain due south of the intersection of Route 42 and Route 624, also a comer with the New Castle and Craig Creek Districts.

Thence, due north to the intersection of Route 42 and Route 624.

Thence, in a northwesterly direction along the top of Johns Creek Mountain to a point on top of Johns Creek Mountain .75 miles west of Alps Knob and also forming a comer of the Potts Mountain District and Simmonsville District.

Thence, in a northwesterly direction to a point in the southern portion of the turn on Route 311 which is approximately 1.1 miles due south of the intersection of Meadow Branch and Route 611, also forming a straight line with the previous two points.

Thence, in a northwesterly direction along Route 311 to a point at the intersection of Route 311 and Johns Creek.

Thence, in an easterly direction along Johns Creek to a point at the intersection of Johns Creek and Craig Creek, point of beginning.

One member of the board of supervisors shall be elected from each election district.

Sec. 18-32. Precinct boundaries.

The boundaries of the respective precincts are as follows:

Ammendale Precinct—Craig Creek District

Beginning at corner of Craig County and Montgomery County, at the top of Sinking Creek Mountain.

Thence, in a southeasterly direction, following the boundary line between Craig County and Montgomery County, to corner, "I" on the old Craig County Survey, corner of Roanoke County, Botetourt County, and Craig County.

Thence, continuing in a northeasterly direction, following Botetourt County line to corner "L" on the old Craig County Survey, corner to Roanoke County, Botetourt County, and Craig County.

Thence, continuing in a northeasterly direction, following the Botetourt County line along the top of North Mountain to a point where Route 618, also known as U.S. Forest Service Route 183 intersects the county line.

Thence, in a southwesterly direction along U.S. Forest Service 183 and State Route 618 to the point where Route 618 intersects Route 311.

Thence, in a northern direction along Route 311 to the point where Route 311 intersects with Meadow Creek, just south of New Castle.

Thence, upstream with Meadow Creek, following a portion of the National Forest Boundary, to the point where it intersects with the National Forest Boundary just south of Route 42.

Thence, in a southern direction, along the National Forest Boundary and along the ridge, to the top of Sinking Creek Mountain.

Thence, in a southwesterly direction along the ridge top of Sinking Creek Mountain, to the corner of Craig County and Montgomery County, being the same point as the starting point.

North Mountain Precinct—Craig Creek District

Beginning at a point on the Botetourt County line at top of North Mountain where U.S. Forest Service Route 183 intersects the Craig-Botetourt County line.

Thence, in a northeasterly direction, following the Botetourt County line, to a point where Route 606 intersects the County line.

Thence, in a southwesterly direction, along the centerline of the right-of-way of Route 606 to the point where Craig Creek intersects Route 614.

Thence, in a southwesterly direction along Route 614 to a point at the intersection of Route 614 and Craig Creek.

Thence, upstream with Craig Creek to the point where it intersects with Johns Creek.

Thence, upstream with Craig Creek to the point where it intersects with Meadow Creek.

Thence, upstream with Meadow Creek to the point where it intersects with Route 311.

Thence, in a southern direction along Route 311 to the point of intersection with Route 618.

Thence, along Route 618, which becomes U.S. Forest Service Route 183, to a point where Route 183 intersects the Craig-Botetourt County line, being the same point as beginning.

Givens and Reynolds Store Precinct—Simmons ville District

Beginning at the corner of Craig County, Montgomery County and Giles County.

Thence, in a northern direction, along the top of Sinking Creek Mountain and the Montgomery County line to the sharp corner in the Craig-Montgomery County line.

Thence, in a northern direction, along the top of Sinking Creek Mountain, to a point 11,300 feet from the previous point at the Craig County line.

Thence, directly perpendicular to Sinking Creek Mountain, 2,250 feet down the western side of Sinking Creek Mountain.

Thence, following an intermittent stream, to a point on Route 42 which is 3,700 feet northeast of the intersection of Route 42 and Route 629.

Thence, following the small stream downstream short distance to the intersection with Sinking Creek.

Thence, downstream with Sinking Creek approximately 1,700 feet to the point of intersection of Sinking Creek and an unnamed smaller creek that enters from the northwest, also being at a sharp bend in Sinking Creek.

Thence, upstream with the small unnamed creek in a northerly direction, following the northern fork to the intersection with Route 624.

Thence, in a northeasterly direction along Route 624 to a point at the third intersection of Route 624 and Farrier Branch.

Thence, following Farrier Branch upstream in a northeasterly direction to its origin on the eastern side of Johns Creek Mountain.

Thence, continuing perpendicular to Johns Creek Mountain to a point on top of Johns Creek Mountain, approximately 10,500 feet due south of U.S. Geologic Survey benchmark number 1739.

Thence, in a southwesterly direction along the top of Johns Creek Mountain, following Johns Creek Mountain Trail, also known as Forest Service Trail 57-2, to a point with the intersection of the Appalachian Trail.

Thence, in a southerly direction along the Appalachian Trail, to an unnamed knob just north of Kelly Knob.

Thence, due south to a point on the Giles County and Craig County line just west of Kelly Knob.

Thence, in a southern direction along the Craig County line to the corner with Montgomery County and Giles County, being the same point as beginning.

McGuire's Store Precinct—Simmons ville District

Beginning at a point at the top of Sinking Creek Mountain at the intersection with Forest Service Route 209.

Thence, in a southwesterly direction along the top of Sinking Creek Mountain to a point 13,600 feet from the previous point, also being a point in common with the Givens and Reynolds Store Precinct.

Thence, directly perpendicular to Sinking Creek Mountain, 2,250 feet down the western side of Sinking Creek Mountain.

Thence, following an intermittent stream, to a point on Route 42 which is 3,700 feet northeast of the intersection of Route 42 and Route 629.

Thence, following the small stream downstream short distance to the intersection of with Sinking Creek.

Thence, downstream with Sinking Creek approximately 1,700 feet to the point of intersection of Sinking Creek and an unnamed smaller creek that enters from the northwest, also being at a sharp bend in Sinking Creek.

Thence, upstream with the small unnamed creek in a northerly direction, following the northern fork to the intersection with Route 624.

Thence, in a northeasterly direction along Route 624 to a point at the third intersection of Route 624 and Farrier Branch.

Thence, following Farrier Branch upstream in a northeasterly direction to its origin on the eastern side of Johns Creek Mountain.

Thence, continuing perpendicular to Johns Creek Mountain to a point on top of Johns Creek Mountain, approximately 10,500 feet due south of US. Geologic Survey benchmark number 1739.

Thence, in a northeasterly direction along the top of Johns Creek Mountain to a point triangulated by two lines; one 13,500 feet from Chimney Rock (on top of Sinking Creek Mountain) and another 20,500 feet from Chestnut Grove Church in Looney.

Thence, perpendicular to Johns Creek Mountain, following an old fence row down the eastern face, crossing Meadow Creek to the intersection with a private farm road.

Thence, in an easterly direction, 750 feet along the private farm road to a point with the intersection of Route 624.

Thence, in a westerly direction along Route 624 approximately 1500 feet to a point with the intersection of small private road that leads off to the south.

Thence, in a southerly direction along the private road approximately 2,500 feet to a point where a trail forks to the right.

Thence, along the trail in a southerly direction approximately 3,500 feet to the intersection with Route 42, near U.S. Geologic Survey benchmark 2589.

Thence, in a southwesterly direction, along Route 42 to the intersection with Sinking Creek.

Thence, in a easterly direction, upstream with Sinking Creek, following the right fork up to the top of Sinking Creek Mountain to point 1,700 feet southwest of Chimney Rock.

Thence, in a southeasterly direction, along the top of Sinking Creek Mountain to the point of intersection with Forest Service Route 209, being the same point as beginning.

Marshall's Store Precinct—Simmons ville District

Beginning at a point at the top of Sinking Creek Mountain, 1,700 feet southwest of Chimney Rock, being a point in common with the McGuire's Store Precinct.

Thence, in a northeasterly direction along the top of Sinking Creek Mountain to a point 2,400 feet due south of the intersection of Route 624 and Route 42.

Thence, due north to the intersection of Route 42 and Route 624.

Thence, in a northwesterly direction to a point on the top of Johns Creek Mountain, .75 miles west of Aps Knob which is the same point in common with the Potts Mountain and New Castle Districts.

Thence, in a southwesterly direction along the top of Johns Creek Mountain to a point triangulated by two lines; one 13,500 feet from Chimney Rock (on top of Sinking Creek Mountain) and another 20,500 feet from Chestnut Grove Church in Looney.

Thence, perpendicular to Johns Creek Mountain, following an old fence row down the eastern face, crossing Meadow Creek to the intersection with a private farm road.

Thence, in an easterly direction, 750 feet along the private farm road to a point with the intersection of Route 624.

Thence, in a westerly direction along Route 624 approximately 1500 feet to a point with the intersection of small private road that leads off to the south.

Thence, in a southerly direction along the private road approximately 2,500 feet to a point where a trail forks to the right.

Thence, along the trail in a southerly direction approximately 3,500 feet to the intersection with Route 42, near U.S. Geologic Survey benchmark 2589.

Thence, in a southwesterly direction, along Route 42 to the intersection with Sinking Creek.

Thence, in an easterly direction, upstream with Sinking Creek, following the right fork up to the top of Sinking Creek Mountain to point 1,700 feet southwest of Chimney Rock, being the same point as beginning.

Court House Precinct—New Castle District

Beginning at the intersection of Johns Creek and Craig Creek, a common corner with Craig Creek District and Craig City District.

Thence, upstream with Craig Creek to the point where it intersects with Meadow Creek.

Thence, upstream with Meadow Creek to the point where it intersects with National Forest Boundary just south of Route 42.

Thence, in a southern direction, along the National Forest Boundary, to the point on the top Sinking Creek Mountain due south of the intersection of Route 42 and Route 624, also a corner with the New Castle and Craig Creek Districts.

Thence, due north to the intersection of Route 42 and Route 624.

Thence, in a northwesterly direction along the top of Johns Creek Mountain to a point on top of Johns Creek Mountain. 75 miles west of Alps Knob and also forming a corner of the Potts Mountain District and Simmonsville District.

Thence, in a northwesterly direction to a point in the southern portion of the turn on Route 311 which is approximately 1.1 miles due south of the intersection of Meadow Branch and Route 611, also forming a straight line with the previous two points.

Thence, in a northwesterly direction along Route 311 to a point at the intersection of Route 311 and Johns Creek.

Thence, in an easterly direction along Johns Creek to a point at the intersection of Johns Creek and Craig Creek, point of beginning.

Craig City Precinct—Craig City District

Beginning at the intersection of Route 611 and Route 615 near Barbours Creek.

Thence, in a westerly direction along Route 611 to the point where Route 611 intersects with Route 311.

Thence, in a southeasterly direction along Route 311 to the point where Route 311 intersects with Johns Creek.

Thence, in an easterly direction along Johns Creek to the point where Johns Creek intersects with Craig Creek.

Thence, in a northeasterly direction along Craig Creek to the point where Route 614 crosses Craig Creek.

Thence, in a northeasterly direction along Route 614 to the point where Route 614 intersects Route 615.

Thence, in a northeasterly direction along Route 615 to the point where Route 615 intersects Route 611, the starting point.

Forks of Johns Creek Precinct-Potts Mountain District

Beginning on the West Virginia line on top of Potts Mountain at the boundary between the old (prior to 1970) Simmonsville and Alleghany Districts, also being a point near Arnolds Knob.

Thence, in a southerly direction along the old (prior to 1970) dividing line between the Simmonsville and Alleghany Districts to a point on the top of Johns Creek Mountain common with the Givens and Reynolds Store and McGuire's Store Precincts.

Thence, in a southwesterly direction along the top of Johns Creek Mountain to the intersection of Johns Creek Mountain Trail, also known as Forest Service Trail 57-2, and the Appalachian Trail.

Thence, in a southerly direction along the Appalachian Trail to a point on top of the unnamed knob just north of Kelly Knob.

Thence, due south to a point on the Giles County and Craig County line just west of Kelly Knob.

Thence, in a northerly direction along the Giles County line to a point at the intersection with the West Virginia border.

Thence, in a northeasterly direction along the border with West Virginia to a point on the top of Potts Mountain at the boundary between the old (prior to 1970) Simmonsville and Alleghany Districts, also being a point near Arnolds Knob and the same point of beginning.

Craig Springs Precinct—Potts Mountain District

Beginning on the West Virginia line on top of Potts Mountain at the boundary between the old (prior to 1970) Simmonsville and Alleghany Districts, also being a point near Arnolds Knob.

Thence, in a southerly direction along the old (prior to 1970) dividing line between the Simmonsville and Alleghany Districts to a point on the top of Johns Creek Mountain common with the Givens and Reynolds Store and McGuire's Store Precincts.

Thence, in a northeasterly direction along the top of Johns Creek Mountain to a point on top of Johns Creek Mountain .75 miles west of Aps Knob, also being a corner of the Simmonsville, New Castle and Potts Mountain Districts.

Thence, in a northwesterly direction to a point in the southern portion of the turn on Route 311 which is approximately 1.1 miles due south of the intersection of Meadow Branch and Route 611, also forming a straight line with the previous point and a point at the intersection of Route 624 and Route 42.

Thence, in a northwesterly direction along route 311 to a point at the intersection of Route 311 and Route 611.

Thence, in a northeasterly direction along Route 611 to a point at the intersection of Route 611 and Route 617.

Thence, in a northerly direction along Route 617 to a point at the intersection of Route 617 and Forest Service Route 176.

Thence, in a northerly direction along Forest Service Route 176 to point at the intersection of Route 176 Forest Service Route 177-1.

Thence, in a southwesterly direction along Forest Service 177-1 to a point at the intersection of Route 177-1 and Route 311.

Thence, in a northerly direction along Route 311 to a point at the intersection of Route 311 and Route 602.

Thence, in a westerly direction along Route 602 to a point at the intersection of Route 602 and the West Virginia line.

Thence, in a southwesterly direction along the West Virginia line to a point on the top of Potts Mountain at the boundary between the old (prior to 1970) Simmonsville and Alleghany Districts, also being a point near Arnolds Knob and the same point of beginning.

Paint Bank Precinct—Potts Mountain District

Beginning at a point at a point at the intersection of Route 176 Forest Service Route 177-1, also being a common corner with the Craig Springs Precinct.

Thence, in a southwesterly direction along Forest Service 177-1 to a point at the intersection of Route 177-1 and Route 311.

Thence, in a northerly direction along Route 311 to a point at the intersection of Route 311 and Route 602.

Thence, in a westerly direction along Route 602 to a point at the intersection of Route 602 and the West Virginia line.

Thence, following the Craig County line around in a northerly direction to a point on top of Peters Mountain, being the intersection of the West Virginia, Craig County and the Alleghany County lines and shown as "B" on the old Craig County survey. Thence, in a southeasterly direction along the Craig County line to a point where the Craig County line nearly intersects a sharp turn in Forest Service Route 176.

Thence, in a southerly direction along Forest Service Route 176 to a point at the intersection with Forest Service Route 177-1, being the same point as beginning.

Barbours Creek Precinct—Potts Mountain District

Beginning at a point at the intersection of Route 617 and Route 611, also being a corner with the Craig Springs Precinct.

Thence, in a northerly direction along Route 617 to a point at the intersection of Route 617 and Forest Service Route 176.

Thence, in a northerly direction along Forest Service Route 176 to point at the intersection of Route 176 Forest Service Route 177-1, also being a comer with the Craig Springs and Paint Bank Precincts.

Thence, in a northerly direction along Route 176 to the sharp turn in Route 176 near the intersection with the Craig County line.

Thence, in an easterly direction along the Craig County and Alleghany County line to a point to which Alleghany County, Botetourt County and Craig County join and shown as "N" on the old Craig County Survey.

Thence, in a southerly direction along the Craig County and Botetourt County line to a point at the intersection of Route 606 that is also a comer for the Craig Creek and Potts Mountain Districts.

Thence, in a northwesterly direction along Route 606 to the intersection of Route 614.

Thence, in a southwesterly direction, along the centerline of the right-of-way of Route 614 to the point where Craig Creek intersects Route 614.

Thence, upstream with Craig Creek, past the first intersection with Route 614 to the point where it intersects Route 614 a second time.

Thence, in a northwesterly direction along Route 614 to the intersection with Route 615.

Thence, in a northerly direction along Route 615 to the intersection of Route 611.

Thence, in a westerly direction along Route 611 to the point of intersection with Route 617, being the same point as beginning.

Sec. 18-34. Notification of adopted changes.

The general registrar of Craig County, Virginia shall, in accordance with Code of Virginia § 24.2-306, as amended, and all regulations of the Virginia Board of Elections, notify by mail of the adopted changes to all registered voters whose election district or polling place is changed at least 15 days prior to the next general, special or primary election.

**AN ORDINANCE DESIGNATING A
CENTRAL ABSENTEE VOTER PRECINCT
IN CRAIG COUNTY, VIRGINIA**

Purpose

In order to comply with the Help America Vote Act, and other state and federal voting laws, and to maintain orderly and accurate elections, a Central Absentee Voter Precinct ("CAP") is hereby established for the purpose of processing absentee ballots for all elections in the County,

Location

The CAP shall be located in the General Registrar's Office for the County of Craig located at 155 Main Street, New Castle, Virginia 24127

Operations

The CAP shall be operated and controlled by the General Registrar and Electoral Board, and shall receive, count and record absentee ballots cast in the County of Craig, as provided by Va. Code Section 24.2-712.

This Ordinance shall take effect immediately for the next general election and all subsequent elections held within the County of Craig.
