A RESOLUTION AMENDING THE FISCAL YEAR 2020-2021 BUDGET

WHEREAS, the Craig County Board of Supervisors (CCBoS) adopted the 2020-2021 Budget on May 7, 2020 for planning purposes, and

WHEREAS, the Animal Control has received the amount of \$85 from the purchases of Animal Friendly DMV tags purchased from Craig Co citizens, these funds must go for the support of dog and cat sterilization programs, these funds will be sent to Angels of Assisi for the cost of these programs, and

WHEREAS, the Circuit Court Clerk office has received the amount of \$1,805 from the State Compensation Board of Virginia for PC's for her office, the clerk has requested that this be appropriated in the clerk budget for the cost of the new PC's, and

WHEREAS, the Craig County Tourism Commission has unspent revenue in the FY20 budget year of \$4,500, it is their request to have this money appropriated into the current budget for expenses in marketing and,

WHEREAS, the Library has received additional funding in the amount of \$511 from the Commonwealth of Virginia from the Library of Virginia, they have requested this funding be placed in the salaries, and

THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Craig County that the Fiscal Year 2020-2021 budget is hereby amended as follows:

B. Resolution Approving RVARC Charter Membership Changes: Mr. Bailey made a motion, seconded by Mr. Dunne, to approve Resolution R21-29. Voting was as follows: Mr. Zimmerman, yes, Ms. Toelke, yes, Ms. Dunne, yes, Mr. Bailey, yes and Mr. Spence, yes.

Authorizing the Roanoke Valley-Alleghany Regional Commission to Amend its Charter to Reduce Membership Requirements

WHEREAS, the Roanoke Valley-Alleghany Regional Commission ("The Commission") is seeking to amend its charter to reduce the number of Commissioners serving on its Board from 38 to 30; and

WHEREAS, in April of 2019 the Chair of the Roanoke Valley-Alleghany Regional Commission directed Commission staff to review the board size of peer Commissions, absentee and attendance data of the Commission, and requirements of the Code of Virginia regarding the Commission's board structure; and

WHEREAS, the Roanoke Valley-Alleghany Regional Commission board was determined to be the second largest board in the Commonwealth, behind only the Hampton Roads Planning District Commission with 47 members; and

WHEREAS, it was determined that under current Charter rules and population forecasts the Commission Board was expected to grow even larger in 2022 with an additional member from the City of Roanoke, bringing the total to seven representatives comprised of four elected officials; and

WHEREAS, a Restructuring Committee was formed in October of 2020 to review staff research and produce a recommendation to the full Board; and

WHEREAS, after reviewing the research and conferring with their local governing bodies as well as chief administrative officers for Commission member jurisdictions, the members of the Restructuring Committee recommended changes to the membership formula for the Commission Board; the addition of a provision for alternate members of the Board to provide flexibility to member governments; and clarification on the definition of Population for purposes of determining membership; and,

WHEREAS, the Commission Board voted to accept the recommendations of the Restructuring Committee at the February 25, 2021 meeting of the Commission; and,

WHEREAS, Article II, Section 1 of the Charter shall be amended to read: "The membership of the Roanoke Valley-Alleghany Regional Commission shall be composed of representatives of the member governmental subdivisions, on the basis of two members from each governmental subdivision, at least one of whom is an elected member of the governing body of the subdivision. In addition, each governmental subdivision with population in excess of 25,000 and less than 50,000 shall appoint one additional member who must be an elected official of the governing body of the subdivision. Each governmental subdivision with a population in excess of 50,000 shall further appoint one additional member, who may but need not be an elected official of the governing body of the subdivision, provided that at least a majority, but not substantially more than a majority, of the Commission members shall be elected officials of the governing bodies of the governmental subdivisions. In determining the population of counties, the numerical total shall be exclusive of participating towns who have a population of three thousand, five hundred; said towns are eligible to have at least two representatives; and

WHEREAS, Article II, Section 2 of the Charter shall be amended to read: ""Population," unless a different census is clearly set forth, means the number of inhabitants according to the United States census latest preceding the time at which any provision dependent upon population is being applied, or the time as of which it is being construed, unless there is available an annual estimate of population prepared by the Weldon Cooper Center for Public Service of the University of Virginia, which has been filed with the Department of Housing and Community Development, in which event the estimate shall govern."; and

WHEREAS, Article II, Section 6 shall be added to the Charter, reading: "Each governmental subdivision of the Commission shall have the option of appointing an alternate member. An alternate member shall be entitled to receive notice of all meetings of the

Commission and of all meetings of committees of which the appointed member is a part, and to attend and vote at any such meeting at which the appointed member is not personally present. When appointing alternates for an elected official of the governing body, the governmental subdivision must appoint a member of the same governing body."; and

WHEREAS, any changes to the Commission charter must be approved unanimously by the governing bodies of all Commission member jurisdictions.

NOW THEREFORE BE IT RESOLVED that Craig County approves the Charter changes of the Roanoke Valley-Alleghany Regional Commission.

BE IT FURTHER RESOLVED that aforementioned Charter changes of the Roanoke Valley-Alleghany Regional Commission will become effective on July 1, 2022, and that the resulting reduction in Board size will be reached through attrition of existing Board members whose terms end on or after July 1, 2022.

The Board of Supervisors of Craig County, in a regular meeting on 1st day of April 2021 adopted this Resolution.

WHEREAS, the Virginia Department of Social Services requires that the Board of Supervisors ratify By-Laws for the Community Policy & Management Team, and

WHEREAS, the Community Policy & Management Team has recently made some changes to their By-Laws and would like the revised version they adopted at their March 17, 2021 meeting, to be considered by the Board of Supervisors for ratification, now

THEREFORE BE IT RESOLVED by the Board of Supervisors of Craig County that the revised By-Laws, adopted at their March 17, 2021 meeting and submitted this day by the Community Policy & Management Team, are hereby ratified.

The Board of Supervisors of Craig County, in a regular meeting on 1st day of April, 2021 adopted this Resolution.

A Resolution Approving the Request of Emergency Services-911 Coordinator for Reverse 911 System

WHEREAS, the Board of Supervisors determined after a presentation from Jim Cady, Emergency Services Manager and Robert Wrzosek, 911 Coordinator that there was a need in Craig County for a Reverse 911 System, and

WHEREAS, the Reverse 911 System provided by OnSolve CodeRed, helps government agencies easily deliver geo-targeted, urgent messages to their communities, and

WHEREAS, the Board of Supervisors determined that the Reverse 911 System is needed for the safety of the citizens of Craig County, and

WHEREAS, the Board of Supervisors approved the implementation of the system with the initial annual fees of \$3,300 per year with funds from the CARES Act funds paying for the first several years and thereafter the County would budget for the cost,

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of Craig County that the implementation of the Reverse 911 System is approved for use by the Emergency Services Operations and the 911 Coordinator.

The Board of Supervisors of Craig County, in a continuation meeting on the 18th day of March 2021 approved this purchase and adopted this resolution at a regular meeting on the 1st day of April 2021.
