Brian Blevins, VDOT: Mr. Blevins gave the update, reported that Ashley Smith will be moving over to Roanoke and Robin Keeler will be moving over to maintenance and we will be seeing her more often. Middle and Main project funds were reallocated, project is still there but looking for way to fund it. No land development projects, 4 private entrances have been added. Still continuing with pavement patching, mowing, and trimming on 621, and working on stone and grading throughout the county adding stone as needed. Upcoming pipe replacements on 632 Johns Creek Rd and 673 Maple Avenue. Bridge Replacement over Meadow Creek in underway and we see back up in the evening. Mr. Zimmerman commented on the bridge being closed for a month with no work. Mr. Zimmerman was concerned about manufactured housing and concern for a 9-foot, one lane, bridge. Mr. Blevins said he would update us and send report to Mr. Collins. Mr. Bellassai mentioned the light on the bridge is not timed properly for emergency services. Mr. Blevins he would take care of it.
 - Ashley Smith gave her presentation on our Secondary Six Year Plan-Reviewed added roads and funding for those rural rustic projects. Northside discussed and will be paved in 2027 and 2028. Ashley requested public hearing in June and pass a resolution for any projects for 2022 and 2023. Mr. Dunbar asked about 621 Upper Craigs Creek and to continue discussion on resurfacing where Hall Road it. Mr. Zimmerman commented on Hall and Draft and Ashley commented it was not added to the plan. Robin Keeler will be here for the next couple of meetings. - B. Trace Bellassai, Broadband: Grant cycle will open back up for VATI and released new guidelines.
