BRIEFINGS

- A. Brian Blevins, VDOT: Mr. Blevins introduced himself to the Board of Supervisors and provided a quick report regarding his background with VDOT. Ashley Smith, VDOT: Updated the Middle and Main Drainage Project, no new information still reevaluating cost of the project. We are working on the potholes and trying to find where the utilities are to address the issues. No land development or permit issued this month. Working on pavement patching, mowing and pipe replacement. Bridge project on 311, outside of town message board will go out next week, detour star March 14th and be in place till Spring 2023. Somewhat restrictive fee Limit reduction, a temporary signal and lanes reduced to 9fht, will be restrictive to equipment and trucks. I have notified Fire and EMS Schools system about the detour. Bridge posting on the bridge 615, goes over Mill Creek north of Peaceful Valley Road, right now its posted at 40 tones, we will be working on different posting for tonnage, won't affect EMS/FIRE or School buses but will affect big Trucks. Will be posted next week. Mr. Bailey asked for clarification on which bridge on Peaceful Valley Road. Ashley clarified the bridge over Mill Creek. Mr. Matyas addressed Ash Trees, specifically near Huffman and Northside Road, new trees that are down and come in the road. Ashley responded that they are working on the Ash Tree contract for all counties and will investigate
- B. MVP-Information item in information, posting to the DEQ
- C. Reassessment Information from Dan Collins-Important because we are funding forty thousand this year and next year's budget eighty thousand. It is covering 2 budget year's and important especially the way the economy is. Refer to the document, Economics by the numbers, Consumer price index, 11 out of 18 effect every citizen in Craig County and 3 out of top 5 effect Craig County Citizens that are purchasing gas, household goods, and groceries. Craig County Citizens are paying forty percent more for gas for example. Valuation of homes in New Castle homes have increased thirty percent in this year alone, reassessment will really be a big jump. Housing market going up, it will be difficult reassessment and by the code of VA §58.1-3321 we are required six years. Law states all properties must be taxed, all taxes shall be uniform, and all assessment will be fair market values. Dan reviewed the roles involved, Board of Supervisors, set the tax rate once reevaluation is complete, Commissioner of Revenue, prepares the taxes, Equalization Board, hears and equalizes complaints, Treasurer to collect taxes. Real estate Taxes are out largest source of revenue. Mr. Spence asked when the assessment will start. Mr. Collins answered, I will advertise for the hire of the Assessment team in August or September and start late December and January.

RESOLUTION APPOINTING REPRESENTATIVE TO REGIONAL POLICY BOARD OF THE ALCOHOL SAFETY ACTION PROGRAM AND REGIONAL COMMUNITY CRIMINAL JUSTICE BOARD

WHEREAS, the Boards of Supervisors of the Counties of Alleghany, Bath, Botetourt, Craig, Roanoke, and the City Councils of the Cities of Covington, Roanoke and Salem have established and operate the Court-Community Corrections Program, a local pretrial services and community-based probation program established and operated pursuant to the provisions of Article 7 of Chapter 1 of Title 9.1 and Article 1 of Title 19.2 of the 1950 Code of Virginia, as amended; and

WHEREAS, the Virginia Comprehensive Community-Corrections Act for Local-Responsible Offenders (Virginia Code § 9.1-173 et seq.) and the Virginia Pretrial Services Act (Virginia Code §19.2-152.2 et seq.) require the establishment and appointment of a Community Criminal Justice Board for the Court-Community Corrections Program; and

WHEREAS, a Regional Community Criminal Justice Board for the Court-Community Corrections Program previously has been established in accordance with law, and this Board of Supervisors, in conjunction with the governing bodies of the other jurisdictions which participate in this multijurisdictional program, deems it appropriate to reconstitute the Regional Community Criminal Justice Board for the Court-Community Corrections Program, pursuant to the authority granted to local governing bodies under Virginia Code §15.2-1411.

NOW, THEREFORE BE IT RESOLVED, pursuant to the authority granted to this Board of Supervisors by Virginia Code §§15.2-1411, 19.2-152.5, 9.1-173, that Lloyd Trevor Nelson Craddock is appointed to represent Craig County on the Regional Policy Board of the Alcohol Safety Action Program and the Regional Community Criminal Justice Board effective July 6th 2017 to complete the unexpired term of Thad Cox for a period of three years, which continued on February 28, 2018, for another three years to February 28th,2021 and appointed for another term, expiring on February 28, 2024.

REPORTS AND INQUIRIES FROM THE BOARD ADMINISTRATOR

- **a.** Mr. Collins presented power point review of the budget that is included in the Budget Workbook given to Supervisors. Presentation including Schedule, preparation of the budget, new budget request, capital improvement items, dept service, CIP and how it affects the budget.
- b. Mr. Collins reported last of the CARE'S funds (Approximately \$98,000) paid for the Radio Equipment Replacement Project. Also, ARAP funds (Approximately \$999,500+/-are eligible for this project. We submitted a VDEM grant request for \$2,900,000 last week. In addition, I have contacted our Delegate (Goth Joe McNamara & Terry Austin) there may be state funding available. Delegate Austin is on the House Appropriations Committee. Still using CARES money for the Radio Equipment Replacement Project. Grant request set at \$2,900,000. We have just applied for it and hoping to get some, part, or all of it.
- **c.** Cleaning Service- For the 6th time in 4 years we are advertising for cleaning services for the Courthouse and Admin Office. Advertisement created three bids Precise Cleaning, Kittens Cleaning, and Obsidian Cleaning Service. Mr. Collins reviewed each bid, spoke about needing contingency money to satisfy lowest bid. Mr. Collins will check references an background check and insurance.
- d. BOS Budget Schedule-Next meeting March 17th at 5:00pm.
- e. EMS new SUV, funded with a 50/50 matching USDA Grant, was delivered this week.
- **f.** Planning Commission will be reviewing a proposed Zoning Ordinance Amendment addressing "Accessory Apartments" (Guest House) this Spring. The purpose is to allow a

- small dwelling, for an immediate family member, on a single lot in various Zones. Updating the Counties Comprehensive Plan will also start his Spring.
- g. Continued efforts with Senator Steve Newman and Delegates Joe McNamara and Terry Austin (Our new Delegate) to fund the "Local Match" for Johns Creek Dam No. 1 Federal safety modifications. Congressman Morgan Griffith's office has been contacted to see if this is an eligible expense under the recently adopted Infrastructure Program.
- **h.** GIS Upgrade GIS is up and running. A new contract for maintenance and service of the GIS system is required for FY23.

HEAR THE PUBLIC

Ms. Dudding commented that she would like to see an in-town service for the cleaning contract.
