BRIEFINGS

- A. Robin Keeler, VDOT: No new land development projects. Continuing with gravel patching, mowing, trimming, and grading on our gravel roads. Update on 311 bridge projects, working on the insuring system on the south side of the bridge and moving to the northside shortly. The environmental permits requires that no administering work be done till the 15th of the month then they will put the bands on and start the demo of the deck and resume construction.
- B. Trace Bellassai, Broadband: Postponing full presentation until next board meeting. RFP (Request for Proposal) is advertised in the paper due to timelines on VATI application. Mr. Bellassai asking the board for \$300.00 dollars for advertising. Mr. Collins commented that he can use one of the two budgets. Mr. Collins asked for a no objection form the board proceed to give the \$300.00 for advertising the RFP as required by law. There is no objection from the board and may proceed with \$300.00 to Broadband committee for advertising RFP.
- C. Darryl Humphreys, EMS Report/Presentation: Brief History of EMS, career staff and volunteer staff. Overview of schedule and hires over the last couple years, 2017, 2018, 2021, to date. Informed the board that we are in crisis due to staffing shortage and better offers from other

companies, (Lewis Gale/Carilion/American Medical Response). Met with Mr. Collins on how to recruit new employees, discussed postings, and recruiting from Radford University. Most graduates from Radford University are working for American Medical Response making more money than we can afford. Mr. Humphreys reviewed how shifts are being covered by volunteer and career staff. Mr. Humphreys suggestion is looking for 3- 6 people, for part-time or full time and put them through training. During training the candidates would be paid \$12.00 per hour, the county would send the candidates to school and fund the program with grant money. The candidates would sign a three-year contract with the county. Humphreys is asking for permission to create a Facebook page for EMS as social media is the best way to reach people for his new program. Mr. Humphreys mentioned that if the Governor's request of raising minimum wage would be helpful and the county offering hazard duty retirement supplement to new EMS employees. Mr. Collins gave an overview of the monies available and the options for Mr. Humphreys program. Mr. Humphreys gave an overview of AMR (American Medical Response) cost of Medicare and Medicaid for transport, and billing issues regarding milage. Mr. Humphreys mentioned the difference is AMR can choose or refuse pick up/transport where the county cannot. Discussions with the board regarding the recruiting program Mr. Humphreys suggested. Mr. Collins spoke about the availability of money in the budget could be used for the training program. The Board requested that Mr. Humphreys continue to pursue new hires and recruiting. There is no objection to Facebook or to Mr. Humphreys training program.

WHEREAS, the Fifth Planning Commission (RVARC) dues were over budget by \$14 this is generated by population and they assist us in grants and other projects, and

WHEREAS, the Risk Management Department in the property and liability cost have exceeded the budgeted amount by \$271 and request that this be transferred, now

**A RESOLUTION ESTABLISHING ADMINISTRATIVE GUIDELINES
FOR THE FINANCIAL MANAGEMENT OF ALL
FEDERAL AMERICAN RESCUE PLAN ACT RELIEF FUNDS**

WHERAES, the American Rescue Plan Act of 2021 but primarily from the Coronavirus Relief Fund (CRF) allocations which provided for two (2) allocations, \$498,318.50 and \$505,684.50 from the Commonwealth of Virginia's CARES funding totaling \$1,004,003.00; and

WHERAES, "CARE's Act, Coronavirus Relief Fund and American Rescue Plan Act of 2021 Allocation Guidelines" has been approved by the Board of Supervisors to meet County emergency needs, establish spending categories, and a timeline to purchase and expend CARE's funds, and

WHERAES, a four-man COVID-19/CARE's Act and American Rescue Plan Act of 2021 Review Committee is appointed to review all requests for funds, ensuring that any expenditures are eligible to receive funds, and

WHERAES, the COVID-19/CARE's Act and American Rescue Plan Act of 2021 Review Committee shall consist of; R.R. Dan Collins, Co. Administrator (Chairman), Darryl Humphreys, EMS Coordinator (Emergency Member), Jim Cady (Citizen Member) and Kermit Daniel, FEMA Accounting Specialist (Finance Member), and

WHERAES, County COVID-19 and American Rescue Plan Act of 2021 funds are to support aid in providing material & supplies, EMS personnel costs, and expanding the pandemic preparedness, and

WHERAES, County COVID-19 and American Rescue Plan Act of 2021 funds are available for the Town of New Castle if eligible expenses are identified and requested by the Town, and

WHERAES, County COVID-19 and American Rescue Plan Act of 2021 funds are available for support of other government-related agencies that did not receive funding directly if eligible expenses are identified by the agencies such as the Volunteer Fire Departments, Volunteer Rescue Squads, CCPSA, 911 Center or other eligible County agencies, and

WHERAES, County COVID-19 and American Rescue Plan Act of 2021 funds are available to the Craig County Economic Development Authority for support of possible business financial aid needs, if eligible expenses are identified by the CCEDA, now, therefore, be it

RESOLVED, by the Craig County Board of Supervisors on this 2nd day of July 2020, the acceptance and appropriation of CARES Act and American Rescue Plan Act of 2021 funding and authorizes the County Administrator to oversee the CARE's Act program within the established guidelines of the CARES ACT and this resolution.

Resolution R22-40, a Resolution and Letter Amending the Craig County Bicentennial Scholarship Award and closing Carter Bank and Trust account where Craig County Bicentennial Memorial Fund is held. Mr. Collins gave an overview and history of the Bicentennial Scholarship Award and the reason for the discussion. The monies were held and Carter Bank and Trust and because of the banks recent closing it is now managed at a Carter Bank and Trust in Roanoke. Mr. Collins explained that the letter is for the Treasurer who has requested that we move the account to Farmers and Merchant Bank for the county's convenience. WHEREAS, Total Action for Progress (TAP), which assists citizens in our jurisdiction, is requesting a letter of support for the reauthorization of the federal Community Service Block Grant Modernization Act of 2022, HR 5129. REPORTS AND INQUIRIES FROM THE BOARD

- a. Mr. Collins – ARAP funds eligible for Radio Project. We submitted a VDEM grant request for \$2,900,000.00 last month. In addition, contacted Delegate (Both Joe McNamara & Terry Austin) there may be state funding available. Delegate Austin is on the House Appropriations Committee.
- b. Opioid Settlement – Notified that the County will receive \$371,000.00. Not sure of eligible uses. All proceeds will go into General Fund – Fund Balance.
- c. Cleaning Service – Crew started last week.
- d. BOS Budget Schedule – Next meeting June 2nd, at 6:00 pm.
- e. Planning Commission will be reviewing a proposed Zoning Ordinance Amendment addressing “Accessory Apartments” (Guest House) this Spring. The

purpose is to allow a small dwelling for and immediate family member, on a single lot in various zones. Updating the county Comprehensive Plan will also start this May or June.

- f. Dam #1- Continued efforts with Senator Steve Newman and Delegates Joe McNamara and Terry Austin (Our new Delegate) to fund the “Local Match” for Johns Creek Dam No. 1 Federal safety modifications. Receive notification federal funding, along with the State (Local) matching funds has been approved. No County funds needed.
- g. GIS update- the Registrar has asked that we consider including a voting precinct in the Magisterial District overlay. Will discuss with Hurt & Proffitt.
- h. Landfill- We have advertised landfill Property for sale once again, R/W to be recorded in the Clerk’s Office prior to any possible sale.
- i. Rails to Trails- IN PROGRESS VDOT has completed the first review for developing a Walking/Bike/Horse Trail from New Castle to Eagle Rock in Botetourt County. The next step is the Preliminary Engineering work. Part of the work is to have several Citizen Information Meetings (CIM) to provide the public an opportunity to review and discuss. I recommend the Board appoint a 5-member committee to oversee the development and insure citizen involvement. The Committee should include a representative for the Tourism Commission, National Forest, Field of Dreams, and two others. I would recommend the County Administer be an Ex-official.
- j. Mr. Spence asked is there were any other reports and commented that he would like to further look into the County Wide Parking Ordinance and bring it back into discussion. Mr. Collins agreed.
