Meeting was called to order at 6:00 p.m. by Mr. Spence. The invocation was given by Mr. Matyas, followed with the Pledge of Allegiance.

Mr. Spence asked if there were any changes to the agenda items. Mr. Collins moved VII. D. Transient Occupancy, moved to VIII. Following Public Hearing A.

The Board of Supervisors of Craig County, in a regular meeting on the 2^{nd} day of March 2023 adopted this Resolution.

Mr. Spence asked for a motion on Consent Items, R23-13. Mr. Bailey made a motion, seconded by Mr. Dunbar, to approve Resolution R23-13. Voting was as follows: Mr. Zimmerman, abstain, Mr. Matyas, yes, Mr. Dunbar, yes, Mr. Bailey, yes, and Mr. Spence, yes.

BRIEFINGS

- A. Brandon King, Craig County Building Inspector-Introduction Mr. Collins introduced Mr. King who has a degree in meteorology. Mr. King has all his certificates and will be taking the Building Inspector certification within the year. Mr. King is happy to be here and thanks the board.
- B. Robin Keeler, VDOT No Land Development and one logging Permit Issued 1/20/23 to 02/13/23. No traffic Engineering work order was submitted. Mowing Sinking Creek area and brush cleaning. Ditching and Pipe cleaning, shoulder on route 311 southbound Craig Valley Drive/Paint Bank Road southbound. Patching on Route 311 Salem Ave and Potts Mountain Road. Grading and stone as needed. County wide cleaning up after wind damage. Completed projects, cleaned up trees and opend pipes on Route 311 in the Potts Mount and Paint Bank Areas. Cleared high elevation routes of ice storm hazards, Dead tree removal on Route 611, Peaceful Valley Road and added stone as needed. Bridge Projects Route 311 (New Castle) Bridge Replacement over Meadow Creek, temporary signal, single land traffic configuration, and reduced speed limit is in service. Phase 1 bridge and approaches are complete. Phase 2 southbound side of the bridge and approaches are underway. Abutment B north side concrete is complete. Road construction underway pending weather conditions. Abutment A, concrete completed. Beams installed and rebar for superstructure installed. Deck concrete placement schedule for 2-22-23, pending weather. Multiple challenges impacted the project schedule requiring the signal to remain in place until the March/April 2023 timeframe. Additional roadway approach grading was required, contractor equipment breakdowns have been impacted by supply chain challenges, and the late fall wet weather has flooded the work area and slowed productive work. Asphalt plants are expected to be reopened in March/April 2023 to allow the final approach paving and signal removal. The December date to remove the signal was just a milestone and not the completion date. The actual contract completion date is May 23, 2023 and they are on schedule. 626 Bethel Church Road, route 626 will be closed from 8 am on March 13, 2023 through March 16,2023 at 4:00 pm to allow for the replacement of the existing bridge over Sinking Creek with a concrete slab. The structure is located 0.06 miles from Rte. 624, Little Mountain Road and 1.0 miles from Rte. 42, Cumberland Gap Road. Signs have been installed warning of the closure and the detour is approximately 6.5 miles. Every effort will be made to complete the project as quickly as possible.
- C. Trace Bellassai, Broadband- No Update
- D. Bill Wolfe, Preserve Craig County, Mountain Valley Pipeline No update.
- E. Woody Lipps, Chairman, Craig Valley Railbed Scenic Trail Update-Mr. Lipps supplied a briefing regarding Virginia Tech Extension program looking at economic analysis. Provided parameters for the project as too complex for their program. We will still apply but submit application focusing on social concerns for

- example crimes associated with such trails, types of crimes. Mr. Collins took a moment to thank Mr. Lipps on his work. Mr. Lipps updated the Board that the committee are growing and added EMS and Fire to our meetings. Mr. Lipps explained that the committee is an advisory group to the Board of Supervisors.
- F. Joanna Ryan, Registers Office-Presentation presented to the Board regarding Craig County Redistricting 2021-2022 proposed Precinct Changes. Ms. Ryan reviewed current Craig County Voting Precincts and area of discussion. First boundary change, Back Valley Rd, and Paint Bank VA, currently the precinct boundaries places two residences on this road in Craig Springs precinct. Updating the precinct boundary to us the ridge elevation contour would include these residences in the Paint Bank precinct. Mount Chestnut, currently the precinct boundary placed the two residences in Craig Springs precinct boundaries to use the existing intersections and drainage sections outlining the Craig Woods Subdivision, would include these residences in the Court House precinct along with all other residences in the Craig Woods Neighborhood. Proposed Potts Mountain District Precinct changes would impact ninety-nine voters. Current to the 401 precinct switching to the 403 precinct would add more mileage and time to travel to voter precincts. Proposed is to redraw the line from the intersection of Nimrod Rd and Taylor Branch, Nimrod Rd to Sweet Springs to existing precinct intersection. Craig Springs potion to become Barbours Creek. This will match what we are already doing. We do need the Board to approve so that we can move to next steps for public comment and then public hearing. Looking at May 4th for final approval. Mr. Spence asked the Board of Supervisors if there were any objections, as there were no objections, Ms. Ryan will proceed.
- G. Darryl Humphries, Emergency Management Director-Presented the board with a Medical Claims Assistant review of suggested rates due to rising medical and fuel costs. Mr. Dunbar asked if they were the same as other surrounding counties. Mr. Humphreys confirmed that the cost was the same. Mr. Humphreys did let the Board know that we collect about 80% of the cost, none for Medicaid. Mr. Zimmerman commented that it cost just as much to run the truck for ALS or BLS and would like the same cost for transportation to be the same. Mr. Spence asked for a motion to approve the rate changes. Mr. Dunbar made a motion, Mr. Bailey seconded the motion. Voting as follows, Mr. Zimmerman, yes, Mr. Matyas, yes, Mr. Dunbar, yes, Mr. Bailey, yes, and Mr. Spence, yes.

RESOLUTION TO APPROVE THE COUNTY OF CRAIG'S PARTICIPATION IN THE PROPOSED SETTLEMENT OF OPIOID-RELATED CLAIMS AGAINST TEVA, ALLERGAN, WALMART, WALGREENS, CVS, AND THEIR RELATED CORPORATE ENTITIES

WHEREAS, the opioid epidemic that has cost thousands of human lives across the country also impacts the County of Craig, Virginia (the "County") by adversely impacting the delivery of emergency medical, law enforcement, criminal justice, mental health and substance abuse services, and other services by the County's various departments and agencies; and

WHEREAS, the County has been required and will continue to be required to allocate substantial taxpayer dollars, resources, staff energy and time to address the damage the opioid epidemic has caused and continues to cause the citizens of the County; and

WHEREAS, due to the impacts of the opioid epidemic, the County has claims probable of assertion against Teva, Allergan, Walmart, Walgreens, CVS, and certain of their related corporate entities, for their role in the distribution, manufacture, and sale of the pharmaceutical opioid products that have fueled the opioid epidemic that has harmed the County; and

WHEREAS, the County seeks recovery of the public funds previously expended and to be expended in the future to abate the consequences and harms of the opioid epidemic; and

WHEREAS, settlement proposals have been negotiated that will cause Teva, Allergan, Walmart, Walgreens, and CVS to pay billions of dollars nationwide to resolve opioid-related claims against them; and

WHEREAS, the County desires and intends to participate in the settlements in order to recover its share of the funds that the settlements would provide; and

WHEREAS, the County has previously approved and adopted the Virginia Opioid Abatement Fund and Settlement Allocation Memorandum of Understanding (the "Virginia MOU"), and affirms that these pending settlements with Teva, Allergan, Walmart, Walgreens, and CVS shall be considered "Settlements" that are subject to the Virginia MOU, and shall be administered and allocated in the same manner as the opioid settlements entered into previously with the Distributors and Janssen.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Craig, Virginia, that the County's participation in the proposed settlements of opioid-related claims against Teva, Allergan, Walmart, Walgreens, CVS, and their related corporate entities, is APPROVED.

And, **BE IT FURTHER RESOLVED** by the Board of Supervisors of the County of Craig, Virginia, that the County Administrator and County Attorney are authorized to execute the documents, and take such other actions, necessary to effectuate the County's participation in the settlements, including the required release of claims against settling entities.

Action As A RESULT of PUBLIC HEARING

ORDINANCE NO. 2023-01

ORDINANCE TO AMEND SECTIONS 38-300, 38-303, 38-305, AND 38-307 OF CHAPTER 38, ARTICLE IX—TRANSIENT OCCUPANCY TAX, OF THE CODE OF ORDINANCES OF THE COUNTY OF CRAIG, VIRGINIA

WHEREAS, Virginia Code § 58.1-3819 authorizes the County of Craig, Virginia (the "County") to levy a transient occupancy tax on hotels, motels, boarding houses, travel campgrounds, and other facilities offering guest rooms rented out for continuous occupancy for fewer than 30 consecutive days in such amounts and on such terms as prescribed by the Craig County Board of Supervisors (the "Board of Supervisors") by ordinance; and,

WHEREAS, by Ordinance No. 2021-06 ("Ordinance 2021-06"), adopted on December 2, 2021, the Board of Supervisors repealed, replaced, and reordained the County's transient occupancy tax, due to changes in state law; and

WHEREAS, since the adoption of Ordinance 2021-06, there have been additional changes to state law relating to the administration of transient occupancy taxes; and

WHEREAS, after notice and public hearing as required by law, the Board of Supervisors has determined it to be appropriate and in the best interests of the County to amend Ordinance 2021-06 to conform with state law and local practice.

NOW, THEREFORE, BE IT ORDAINED by the Board of Supervisors of the County of Craig, Virginia, that Sections 38-300, 38-303, 38-305, and 38-307 of Chapter 38, Article IX—Transient Occupancy Tax, of the Code of Ordinances of the County of Craig, Virginia are amended as follows:

<u>Under Section 38-300</u>, the definition of "*Total price paid*" is amended to state:

Total price paid: the total price charged to the customer. It will include the room charge and any fee charged to the customer and retained as compensation, whether described as an accommodations fee, facilitation fee, or any other name.

Section 38-303 is amended to state:

Sec. 38-303. – Exceptions.

No tax shall be payable under this article on room rental paid to any hospital, medical clinic, convalescent home, or home for aged people.

Current Section 38-305 is repealed and replaced with the following:

Sec. 38-305. – Reports and remittance.

- (a) For any retail sale of accommodations facilitated by an accommodations intermediary, the accommodations intermediary must remit the tax imposed pursuant to this article to the Commissioner and, except as provided in subsection (c), shall be liable for the same.
- (b) For any retail sale of accommodations not facilitated by an accommodations intermediary, the accommodations provider must remit the tax imposed pursuant to this article to the Commissioner and, except as provided in subsection (c), shall be liable for the same.
- (c) For any transaction for the retail sale of accommodations involving two or more parties that meet the definition of accommodations intermediary, nothing in this article prohibits such parties from making an agreement regarding which party will be responsible for collecting and remitting the tax, so long as the party so responsible is registered with the Commissioner for purposes of remitting the tax. In such event, the party that agrees to collect and remit the tax will be the sole party liable for the tax, and the other parties to such agreement will not be liable for such tax.
- (d) The person collecting any such tax required pursuant to this article must make out a report on such forms and setting forth such information as the Commissioner may prescribe and require, showing the amount of total room charges collected, and the tax required to be collected, and must sign and deliver the same to the commissioner with a remittance of such tax.
- (e) Such reports and remittances must be made monthly on or before the 20th day of the month and covering the amount of tax collected during the preceding month. If the remittance is by check or money order; it must be payable to the County and all remittances received hereunder by the Commissioner must be promptly delivered to the Treasurer.
- (f) Each accommodations intermediary must submit to the Commissioner the property addresses and gross receipts for all accommodations facilitated by the accommodations intermediary in Craig County on a monthly basis.

Current Section 38-307 is repealed and replaced with the following:

Sec. 38-307. Penalty and interest for nonpayment of tax; failure to report.

If any person shall fail or refuse to remit to the Treasurer any of the taxes required to be collected and paid under this article by the due date, the Treasurer shall collect a late payment penalty of ten percent (10%) of the tax due or \$10, whichever is greater. In addition, there shall be added to such unpaid tax interest at the rate of ten percent (10%) per annum on the

amount of tax delinquent, such interest to commence on the first day of the month following the month in which such taxes are due. If any person shall fail or refuse to submit to the Commissioner the reports required by this article by the due date, the Commissioner shall assess and the Treasurer shall collect a late filing penalty of ten percent (10%) of the tax due or \$10, whichever is greater. Notwithstanding the foregoing, neither the late payment penalty nor the late filing penalty shall exceed the amount of the tax.

And, **BE IT FURTHER ORDAINED** by the Board of Supervisors of the County of Craig, Virginia, that Chapter 38, Article IX—Transient Occupancy Tax, of the Code of Ordinances of the County of Craig, Virginia, shall remain in full, force, and effect as originally set out and adopted in Ordinance No. 2021-06, except as specifically amended, repealed, or replaced by this Ordinance.

This Ordinance shall take effect immediately upon adoption.

OPEN MEETING

Continued Meeting was called to order at 5:03 p.m. by Mr. Spence and continued to work session.

WORK SESSON

Mr. Collins updated the board on the fiscal year 2023-2024 budget schedule. April 6th at 6:00 Board of Supervisors will discuss the school budget with the School Board.

Mr. Collins gave a summery on cost of insurance and family insurance from recent survey. Ms. Kathy Jones collected information from surrounding counties with similar populations, showing the cost of insurance from 50% to 90% coverage. Alleghany county had a unique policy at 80% for coverage for any single employee, dual, or family plan. Mr. Collins reviewed the cost with the Board of Supervisors. Mr. Collins explained that our current plan is up for renewal April 1st however we can change plans and will need commit by April 1st.

Mr. Zimmerman made a motion to adopt plan C, 80% for single, spouse, and family. Mr. Matyas, 2nd the motion. Mr. Zimmerman, yes, Mr. Matyas, yes, Mr. Dunbar, yes, Mr. Bailey, yes, and Mr. Spence, yes. Motion passed.

Mr. Collins reviewed with the Board the Personal Property Tax Relief. As a result, of unusually high used car values, the Board of Supervisors last August, provide addition Tax Relief to the Citizens of Craig County. Used car values increase about 40% last year, to ease the tax burden the Board approved an additional 15% of Personal Tax Relief added to the State Tax Relief. As

reported by several new agencies the Used Car Values have dropped approximately 20% since last year. Roughly half of the values report last year.

Mr. Spence suggested to cut the relief by half or do away with relief as it was a onetime relief. Discussion with the Board consensus was no relief and more conservative. The Board decided not relief.

Mr. Collins informed the Board, the School Board will be here at the next meeting to discuss their budget, delayed this year due to the State. Mr. Matyas requested an update on student numbers before the next meeting.

Mr. Collins reviewed the 2023-2024 Preliminary Budget with the Board of Supervisors, reviewed new funding requests from departments.

Mr. Spence asked if there were any additional funding requests from departments. Ms. Snider, Commissioner of Revenue Interim, thanked the Board for the allocating monies for addition help before Ms. Huffman retired. Ms. Snider gave a brief background to duties and responsibilities of her office. Ms. Snider requested another full-time staff person and increase in salary for her Deputy of Commissioner.

Mr. Spence asked if there were any other requests or budget questions.

Mr. Matyas asked if there was COLA available for Library Staff increase in salaries. Mr. Collins responded the Craig County Library Board would be able to answer.

Review of Budget Calendar, April 6th, meeting with School Board at 6:30 and begin at 6 pm.
