## A Resolution Appointing Nichole Zimmerman To the Craig County Tourism Commission

**WHEREAS,** Membership in the Craig County Tourism Commission (CCTC), in accordance with Resolution R.12-01 passed by the Board of Supervisors of Craig County, will consist of five (5) citizens appointed by the Board with representation as equally distributed around the five magisterial districts as practical.

WHEREAS these representatives shall serve at the pleasure of the Board of Supervisors and may serve unlimited terms. Commission members will serve four (4) year staggered terms. Commission Members Phil Spence and Betsy Daniel have submitted their resignations.

WHEREAS, The Craig County Tourism Commission (CCTC) has nominated Nichole Zimmerman to fill the unexpired term of Phil Spence. Mr. Spence's term ends January 1, 2024. Mrs. Zimmerman would be appointed effective October 7, 2021 and ending January 1, 2024.

## A RESOLUTION AMENDING THE FISCAL YEAR 2021-2022 BUDGET

WHEREAS, the Craig County Board of Supervisors (CCBoS) adopted the 2021-2022 Budget on May 6, 2021 for planning purposes, and

**WHEREAS**, the Commonwealth of Virginia, Compensation Board (Comp Board) has notified the Craig County Sheriff Office of Bonus Funding in the amount of \$3,000 for the Sworn Officers that are supported by the Comp Board, and

WHEREAS, this performance Pay of \$3,000 is a one time bonus from the Commonwealth of Virginia's allocation of American Rescue Plan Act (ARPA) funds in a 2021 General Assembly Special Session for performance Pay, and

**WHEREAS**, the Comp Board will reimburse the county for the \$3,000 each eligible officer plus the counties cost for FICA of \$320, total reimbursement to Craig will be \$22,610 for the 7 officers supported by the comp board, and

WHEREAS, Craig County also has two other Deputies which are totally funded by County funds, it is the request that these two officers also receive the Performance Pay and these funds be used from the Sheriff Budget line item from a vacant salary position, and

**WHEREAS**, the cost for the county funded deputies is \$6,460 and will be paid from the sheriff vacant salaries line by a Budget Transfer Resolution, and,

**THEREFORE**, **BE IT RESOLVED**, by the Board of Supervisors of Craig County that the Fiscal Year 2021-2022 budget is hereby amended as follows:

## A RESOLUTION TRANSFERING FUNDS FOR THE 2021-2022 FISCAL YEAR BUDGET FOR CRAIG COUNTY

**WHEREAS**, the Board of Supervisors is requested to amend the Fiscal Year 2021-2022 budget as presented below, and

WHEREAS, it is the request of the Craig County Sheriff Office to provide performance pay to the two county funded officers as the compensation board is providing to the compensation funded deputies from the ARPA state funds, and

**WHEREAS**, it is also the request of the Sheriff to transfer the total amount of \$6,460 from the unused Salary of SRO for the purpose of providing the two county funded deputies performance pay, and

**WHEREAS**, the amount of \$6,000 will be placed in salaries for Animal Control, and E911 and the amount of 640 will be placed in the FICA line item, and

**WHEREAS**, it is the desire to transfer the above funding from the monies set aside in Contingency for the costs of these described overages, and

- **a.** Mr. Collins advised the board that in the November BOS meeting we will provide the Occupancy Tax Ordinance. This was sent to the attorney on September 1, 2021, for review.
- **b.** Mr. Collins advised the Board that he will be meeting with the Botetourt County Sheriff regarding the Regional Jail Agreement in the coming week to discuss the 30-year agreement.
- **c.** Mr. Spence asked about the Community College Scholarship Program, he asked if there is a difference in Homeschooled children VS Public School Systems.
- **d.** Mr. Toelke asked how the GIS webpage was progressing and when it was going to be available for citizens to review. As she recalls this system was supposed to be available within 6 months of Hurt & Proffitt beginning the project it has now been 1 year. Mr. Collins advised that the tax maps are the delay in this project, accuracy needs to be confirmed prior to releasing this information to the public. Mr. Zimmerman agreed to delay the release until the information posted is more accurate.
